Course Description:

This seminar aims to discuss the methodological, theoretical, and empirical variety of economic history. In contrast to other source and archival based research seminars, the final goal of the seminar is to help students write an in-depth analytical paper based on secondary literature.

This seminar will not provide a survey of classical authors, themes, and approaches but rather, through a selected list of important monographs and papers, will explore the multiple ways of doing economic history. We will focus on the differences, boundaries, and overlaps between qualitative and quantitative approaches as well as between economic history and other fields of historical inquiry like history of science, gender, law and global history.

Discussions will be held in English and German and you may write your short contributions and final research paper in either German or English.

Requirements:

- Regular attendance, preparation and active participation are expected. Please send us a short email in advance to announce your absence.
- Your final grade will be made of two components (Portfolio format)

25% of the final grade: Critical Appraisal of a monograph which will include a thesis and set of questions for discussion

75% of the final grade: Preparation and writing of a field review paper (20-25 pages, 50'000-62'000 characters, bibliography not included)
